

**Level plan at the University of Applied
Sciences Emden/Leer
WS 21/ 22**

A "university incidence value" (HSI – *Hochschulinzidenzwert*) is defined. This is weighted and calculated based on the surrounding area where the newly enrolled students live. The HSI is calculated each day and published on the homepage. The levels will be changed based on an incidence value which remains stable over five consecutive days, and the change will be announced by the committee.
