Your future career field

Immediately after completing your studies, you can be assigned complex tasks to be carried out independently as a young professional. Highly qualified employees who can be deployed universally are particularly sought after in small or medium-sized companies. Also entering a management career is conceivable. In principle, positions in various areas such as industry, service or commercial companies, as well as the public sector and non-profit organisations will be possible for you.

Your degree program

In the first three semesters, the advanced degree program offers you a comprehensive insight into the theoretical and practical management tasks of companies. You will acquire further skills in the areas of business administration, management techniques, project management, as well as economics and law. In the last semester, you will write your Master's thesis. You can either write this as a theoretical thesis or as a practice-oriented one in a company. After four semesters, this degree programme offers you an internationally recognised, advanced degree that prepares you for managerial and responsible tasks in business, the higher civil service or for a possible doctorate.
