TERMS AND CONDITIONS

1. The participant's inscription in the program determines the automatic acceptance of all the academic, disciplinary and other related conditions that USIL establishes.
2. When arriving to the host country, the participant must assist mandatorily to the orientation session that will be offered. Therefore, ignorance of the rules given due to absence or distraction of the participant will not be admitted.
3. The participant leaves in record that USIL has done every foreseeable possible effort and adopted all of the reasonable measures to guarantee the security of the students, and therefore exempts USIL from all liability and/or affectations.
4. The Participant acknowledges that USIL has made all the foreseeable possible effort and has adopted all reasonable measures of care to guarantee the safety of its students, for which it exempts from all type of responsibility and / or effects to USIL, in the acts in who have not expressly intervened, becoming the Participant directly responsible for any act, contract, obligations (whether contractual or extracontractual) and / or liability for any damage, affectation, loss, costs and / or expenses as well as any type of activity carried out in front of a, or contract directly with third parties in a personal capacity and / or in which you have intervened and / or been totally or partially obligated.
5. The Participant exempts the institutions that receive it in the Program, from any eventual liability and / or damage for damages and / or damages in general that may occur during the term of the same, either in his own person or in third parties or goods of third parties, originated by their own conduct or omission.
6. USIL is not responsible for procedures with third parties, such as insurance companies, airlines or travel agencies or tourism, or procedures to return money. Any complaint, suggestion or recommendation must be made directly with the supplier company, even when related to activities planned as part of the PROGRAM.
7. It is recorded that the courses and activities included in the PROGRAM, exceptionally, may undergo changes taking into account external and not foreseeable issues such as the number of students enrolled, problems that may affect the availability of teachers or facilities, etc. , for which USIL must communicate and coordinate on this eventuality to the PARTICIPANTS in order to take the corresponding measures to reduce the effects of these eventual changes, during the development of the program.
8. The participant will be responsible for obtaining his / her passport, visa, medical insurance and in general any requirements that may be necessary to enter the country and perform the activities that are part of the PROGRAM, and in that same sense of records that the Participant disclaims liability to USIL for any non-academic matter, including criminal conduct, assault, loss or theft that is committed by or against the Participant.

In accordance with Law N° 29733 – Law for the Protection of Personal Data and its Rulings approved by Supreme Decree D.S. 003-2013-JUS, the student gives his/her express consent for the personal data provided to be incorporated in the Students, Alumni, Parents and Legal Guardians of Students personal databank of San Ignacio de Loyola University (USIL) and for that information to be used with the purpose of providing an appropriate educational service or, in the case of alumni, for the issuance of certificates upon request, as well as for communicating information concerning new academic programs and institutional activities; such uses may include financial and accounting management activities, monitoring of compliance and lack of compliance with financial obligations and insurance service provision, the management of client lists, profile analysis, publicity and commercial prospection, statistical, historical and scientific activities, the rendering of communication and telecommunication services, the management of lists of associates, associative, cultural, leisure, sport and professional activities, education, medical records, video surveillance, security and control of access to facilities, and the issuance of reports.
