#### General Part (Part A) of the Examination Regulations for Bachelor Programs (BPO)

#### of Emden/Leer University of Applied Sciences

Based upon sec. 7 of the Lower Saxony Higher Education Act (NHG) of 26 February 2007 (Lower Saxony Law Gazette p. 69), last amended by article 1 of the act of 27 January 2022 (Lower Saxony Law Gazette p. 287), the Senate of Emden/Leer University of Applied Sciences decided the following regulations on 28 June 2022. These regulations were approved by the Executive Committee on 29 June 2022 (gazette no. 113, published on 1 July 2022), last amended by the decision of the Senate of 28 January 2025 and the approval of the Executive Committee on 5 February 2025 (gazette no. 151/2025, published on 12 March 2025).

#### Art. 1 Scope

(1) <sub>1</sub>The General Part of the Examination Regulations (Teil A) applies to all Bachelor programs of Emden/Leer University of Applied Sciences. <sub>2</sub>This part governs university-wide examination standards and forms the examination regulations as applicable with the relevant Special Part.

(2)  $_1$ The Special Part of the Examination Regulations (Part B) governs in particular the structure of studies, the standard period of study, the university degree to be awarded, the type, the number, the requirements and the work time of the credits required for passing the Bachelor examination, the preliminary admission to the modules of the Bachelor examination.  $_2$ This part moreover governs the total time of lectures, the admission to the Bachelor thesis as long as not all modules have been passed.

# Art. 2 Study Goal

<sup>1</sup>The Bachelor examination forms the degree qualifying graduates to enter a profession. <sup>2</sup>This examination is designed to determine whether students have acquired both the necessary methodological skills and the qualifications related to the professional field to work in the professional fields of activity on the disciplinary and interdisciplinary contexts in an autonomous manner on a scientific basis.

#### Art. 3 Graduation

<sup>1</sup>Following successful completion of studies, the Bachelor degree is awarded. <sup>2</sup>The university issues a Certificate (Annex 1a) stating the date of the Diploma (Annex 2a) for this degree. <sup>3</sup>Upon request, the student may be issued a translation of the certificate and the diploma (Annex 1b or Annex 2b) in English. <sup>4</sup>The relevant **Part B** governs the degree that is awarded.

#### Art. 4 Scope of Studies and Standard Period of Study

(1) <sub>1</sub>The scope (standard period of study) of the Bachelor studies is no less than three and no more than four years. <sub>2</sub>The standard period of studies may be extended by up to one year in exceptional cases. <sub>3</sub>The standard period of study of each Bachelor program including the Bachelor thesis and the colloquium as well as potential practical phases is governed by **Part B**.

(2) <sub>1</sub>In According to the provisions of the ECTS (European Credit Transfer and Accumulation System), 60 credit points per year of study are generally awarded. <sub>2</sub>As workload for full-time studies, 1,800 work hours per year of study are set. <sub>3</sub>One credit point thus corresponds to a workload of 30 hours for students. <sub>4</sub>Part B may govern different stipulations.

(3) <sub>1</sub>If the standard period of study of the relevant Bachelor program is four years, the Bachelor examination is preceded by a preliminary examination. <sub>2</sub>Such preliminary examination is designed to determine whether the person to be examined has acquired the foundations of their discipline with regard to contents and methodology, and a systematic orientation in order



to continue studies with success. <sub>3</sub>This is set out in more detail in **Part B**. <sub>4</sub>Programs pursuant to art. 1 subsec. 2 are excepted.

(4) Studies are structured and organized so that they may basically be completed within the regular period of study.

# Art. 5 Structurization of Studies

(1) <sub>1</sub>Studies are structured in modules. <sub>2</sub>Modules are self-contained study units well rounded with regard to subjects and time and lead to a partial qualification related to the relevant study goal.

(2) <sub>1</sub>Modules may consist of various forms of teaching and learning (e. g. lectures, seminars, exercises, projects, internships, field trips, company internships, individual self-study). <sub>2</sub>Their duration is generally one semester, however no longer than two semesters. <sub>3</sub>The workload related to the module may also extend to semester breaks.

(3) <sub>1</sub>The contents, structuring, duration and result required of a module laid down in the module catalogue in **Part B** or, apart from the Examination Regulations, in the relevant module description in the module manual. <sub>2</sub>The provisions in the module manual are decided by the Examination Board and shall be properly published within the university before the beginning of the semester. <sub>3</sub>Where necessary, decisions pursuant to subsec. 2 are to be announced with transitional regulations as well as with a date for taking effect. <sub>4</sub>For material amendments to the module manual, reference is made to art. 44 of the Lower Saxony Higher Education Act.

(4) <sub>1</sub>Studies consist of disciplinary parts (subject modules) and interdisciplinary parts. <sub>2</sub>The transdisciplinary parts are designed to predominantly convey key qualifications such as soft skills. <sub>3</sub>Subject modules may be supplemented by interdisciplinary studies. <sub>4</sub>This is set out in more detail in **Part B**.

# Art. 6 Study Requirements, Credit Points, Study Organization

(1)  $_1$ Studies consist of compulsory, compulsory elective and elective modules.  $_2$ Which modules are included in which specialized studies and what status they have in such studies is set out in **Part B**.

- a) Compulsory Modules must be taken and passed by students.
- b) Compulsory Elective Modules must be chosen from a range of modules, taken and passed by students. If more credit points were accomplished in compulsory elective modules than required pursuant to Part B of the Examination Regulations as applicable, the examinations are included in the overall mark with the best marks to the required extent of credit points.
- c) **Elective Modules** may be additionally taken by students at their option if they have free capacities. They will not be taken into account when determining the overall mark. Elective modules are indicated in the transcript of records.
- d) Modules are generally completed by passing the module examination based upon which marks and credit points are awarded. A module examination may by way of



exception structured in several components assessed. In module examinations and partial examinations, various forms of examinations during module studies may be applied. It may be determined in **Part B** that several modules are combined in a **Meta Module**.

(3) For the successful completion of a module pursuant to paragraphs 1a) and b), credit points are awarded in the number stipulated in the module description.

(4)  $_1$ The sequence of modules is recommended in the relevant annex to the subject-specific provisions in **Part B**.  $_2$ This does not affect constraints resulting from the definition of the subject admission requirements for modules.

(5) <sub>1</sub>Mandatory attendance of the lectures at Emden/Leer University of Applied Sciences is justified if considering the type of lecture and the learning goal pursued by it, attendance is suited for promoting the achievement of the learning goal, if attendance is required for achieving the learning goal and if the learning goal cannot be achieved by more lenient means, in particular by way of self-study on one's own or in private working groups. <sub>2</sub>If any such obligation to attend a lecture exists and is not complied with, the student will not be admitted to this examination. <sub>3</sub>Lectures requiring attendance, the modalities for attendance, permissible days of absence shall be stipulated in module manuals. <sub>4</sub>There is generally no obligation to attend lectures.

# Art. 7 Forms of Examinations

(1) <sub>1</sub>It is only possible to a limited extent to retake an examination component. <sub>2</sub>An examination component is graded (art. 11). <sub>3</sub>The result is included in the mark calculation.

(2) 1Study credits are usually provided related to a lecture. 2They have to be passed. 3Study credits may be repeated without any limitation and are evaluated with "pass" or "fail". 4Part B may provide for study credits to be also graded. 5The grade will not be included in any further calculation.

(3) <sub>1</sub>Preliminary work is the admission requirement for an examination component; this means that the examination component may only be taken if preliminary work is proven. <sub>2</sub>Preliminary work may be repeated without any limitation, it may be graded or even be evaluated with "pass" or "fail". <sub>3</sub>The result will not be included in further grading.

# Art. 8 Types of Examinations

(1) The following types of examinations may be taken pursuant to the Special Part of the Examination Regulations (**Part B**):

(2) <sub>1</sub>A **Written Exam** requires the work on a defined appropriate assignment by the common methods of the subjects within a limited period of time by means of previously determined tools and under supervision. <sub>2</sub>The period for the work is stipulated in **Part B**. <sub>3</sub>Written exams may also be performed in the form of multiple choice. <sub>4</sub>A written examination may also be held in electronic form. <sub>5</sub>Students will be given ample opportunity before the examination to become



familiar with the electronic examination system. <sub>6</sub>Data protection regulations shall be complied with.

(3) <sub>1</sub>The **Oral Examination** will take place before two examiners (Panel Examination) or before one examiner and a competent assessor in the form of an individual examination or as a group examination for up to five students simultaneously. <sub>2</sub>The essential subjects of the examination and the relevant considerations of the evaluation of the performance shall be laid down in minutes. <sub>3</sub>It must be signed by the examiners or the examiner and the assessor. <sub>4</sub>The oral examination usually takes thirty minutes per student. <sub>5</sub>The oral examination may also involve assignments to a reasonable extent for written elaboration unless the nature of the oral examination is reversed.

(4) <sub>1</sub>A **Seminar Paper** or a **Student Research Project** is the autonomous written work on a subject-specific or interdisciplinary task. <sub>2</sub>In suitable cases, the solutions developed may also be orally elaborated on in a manner typical for the professional activity.

(5) A **Draft** comprises the work on a subject-specific or interdisciplinary task in conceptual and constructive respects in special consideration of planning aspects.

(6) A **Presentation** is an oral report with subsequent discussion on an independent and advanced written elaboration on an issue from the work context of the lecture, taking into account and evaluating relevant literature.

(7) The Establishment and Documentation of Computer Programs generally includes

- 1. The description of the task and its demarcation
- 2. The creation of theoretical requirements for working on the task including, but not limited to the selection of appropriate methods, taking into account and evaluating relevant literature
- 3. The formulation of the algorithms used in an appropriate programming language
- 4. Testing the program with several exemplary datasets and verifying the results for accuracy
- 5. The program documentation, in particular stating the methods used, describing the approach, the application log (source program) and result log
- 6. The presentation of the program.

(8) In a **Computer Test**, the work on tasks must be performed directly on the computer within a specified time.

(9) **Experimental Work** comprises the theoretical preparation, setup and execution of an experiment as well as a written or oral presentation of the work stages, the test procedure and results of the experiment as well as their critical appraisal.

(10)  $_1$ A **Project Report** is the coherent textual or medial presentation of problems, problem analysis and the results of a project as well as work methods applied.  $_2$ The project report must be elaborated on in a manner typical for the professional activity.  $_3$ The participation in a project may be included in the evaluation.



(11) <sub>1</sub>A **Practical Experience Report** is designed to demonstrate that students are able to connect studies and practice following didactical and methodological instruction and contribute to the usability of the experience and results for teaching. <sub>2</sub>The report moreover generally includes the following:

- 1. An evaluation of the relevant preparatory literature
- 2. A description of the place where the internship was completed
- 3. A description of the tasks assumed during the internship and the results obtained.

(12) A **Professional Exercise** includes the solution of practical assignment in a manner typical to the profession and the explanation and presentation of the approach.

(13) The **Course Work** is an achievement in parallel to a lecture at the option of the examiner pursuant to paragraphs 4 to 10.

(13 a) <sub>1</sub>A Portfolio comprises a certain number of up to five credits (e. g. minutes, essay, review, learning diary, short presentation, exercises, a brief written test). <sub>2</sub>Examination components acc. to paragraphs 2 to 13 are not permissible within a portfolio. <sub>3</sub>The portfolio will be evaluated in its entirety. <sub>4</sub>Art. 8 para. 18 shall apply accordingly.

(14) <sub>1</sub>During **Multiple Choice** Examinations, the person to be examined must answer questions posed in writing under supervision. <sub>2</sub>The examinee must state the answers submitted along with the questions they consider to be correct.

(15) Examinations of another type may be stipulated in **Part B** if they are appropriate and equal to the examination components according to paragraphs 2 to 14 with regard to requirement and procedure.

(16) <sub>1</sub>Suitable types of examinations may be permitted in the form of **Group Work**. <sub>2</sub>The examination board may decide upon the request of the examiner that examinations be only included in the form of a group achievement. <sub>3</sub>Individual students' contributions to be evaluated as a credit must meet the requirements of the examination, and they must be clearly demarcated and separately assessable as an individual examination credit based upon the indication of paragraphs, page numbers or other objective criteria.

(17) <sub>1</sub>Special needs of students with disabilities or with chronic diseases or pregnant students based upon the protection provisions of the German Maternity Protection Act will be considered by an appropriate compensation of disadvantages regarding module examinations if the limitations are set out credibly in an application that a module examination may not be taken in whole or in part in the prescribed form. <sub>2</sub>Unless the limitation is obvious, the application must be accompanied by a medical certificate stating the limitation regarding the examination. <sub>3</sub>Upon request, a certificate by a medical officer must be submitted. <sub>4</sub>The application pursuant to subsection 1 must be filed no later than until the registration for the examination. <sub>5</sub>Measure compensating for disadvantages must not affect the evaluation of module examinations and not be included in academic records. <sub>6</sub>Subsections 1 to 5 shall accordingly also apply to students with children or relatives in need of care, relevant proof must be enclosed to the application.



(18) If several types of examination are provided for one module, the type of the examination will be announced within three weeks after the start of lectures.

(19) <sub>1</sub>Examiners may also choose a type of examination other than those stipulated in the module catalogue in agreement with students as well as with the consent of the examination board. <sub>2</sub>The examination board will refuse its consent if equivalence cannot be ensured. <sub>3</sub>The type of examination will be published within the university. <sub>4</sub>Paragraph 18 shall accordingly apply. <sub>5</sub>The deadline may be extended in the event of existing limitations and obstacles due to a pandemic, epidemic or another significant event. <sub>6</sub>In any such case, the amendment shall be announced within the university no later than fourteen days before the date of the examination.

(20) <sub>1</sub>Examinations suited by their nature to be held in electronic form without the obligation to be personally present in a specified examination room, may be held in the form of electronic distance examinations. <sub>2</sub>Electronic distance examinations will be held based upon the "Framework Regulations for Electronic Distance Examinations of Emden/Leer University of Applied Sciences".

#### Art. 8 a Internships, Training Modules and Practical Semesters

 $_1$ The duration of internships, training modules and practical semesters is governed in Part B of the Examination Regulations of the relevant programs.  $_2$ Where a longer period of time is necessary for the internship in order to achieve the training purpose, the period may be determined to be no longer than six months in justified cases.  $_3$ The extension will be decided by a university supervisor.

#### Art. 9 Public Oral Examinations

 $_1$ Students who wish to take the same examination in the future as well as other members of the university who claim their own justified interest shall be admitted as audience.  $_2$ This rule does not extend to the communication and disclosure of examination results to students.  $_3$ Auience members shall be excluded upon the request of the person to be examined.  $_4$ For the colloquium, company supervisors may be admitted as audience upon the request of the person to be examined.

#### Art. 10 Registration Periods, Examination Periods, Program Deadlines

(1) <sub>1</sub>For each examination credit, students are required to apply for admission within the period stipulated by the examination board (Examination Registration). <sub>2</sub>The examination board will determine the form, body and period for the application for registration.

(2) <sub>1</sub>The choice of study focuses and fields of study or specializations shall be made when initially registering for a relevant examination. <sub>2</sub>For study programs offered in a university network, other provisions may be set out in **Part B**. <sub>3</sub>**Part B** may provide that a change is only possible upon the consent of the examination board or that it is excluded.



#### (3) Not applicable

(4) 1Students shall have the opportunity to withdraw their examination registration for a written exam no later than by expiry of the calendar day before the examination on the online portal. <sup>2</sup>For all other types of examination, students shall have the opportunity to withdraw their examination registration no later than by a date set by the examination board. <sup>3</sup>The examination board will determine the form and body for filing the withdrawal. <sup>4</sup>Art. 16 shall apply to withdrawals.

(5) Unless otherwise provided in this part and in **Part B**, those students will be admitted who are enrolled in the **relevant program**, bring proof on proper studies and have passed the modules, preliminary credits and course credits required.

(6) <sub>1</sub>By the end of the **Second Semester**, the student is required to have provided modules to the extent of **40 credit points** in the modules under **Part B**. <sub>2</sub>If the deadline is exceeded, a certification shall be issued to the effect that the student is at risk to be disenrolled due to **ultimately failing** the study program unless he provides the 40 credit points required **by the end of the third semester**. <sub>3</sub>Unless these 40 credit points are obtained by the end of the third semester for reasons within the student's responsibility, the student "**ultimately failed**" such program and will be **disenrolled**. <sub>4</sub>Art. 16 para. 2 shall apply to justifications for exceeding the deadlines pursuant to subsection 3. <sub>5</sub>**Part B** may provide differing regulations with regard to the number of credit points to be obtained and the period within which to provide the credit points.

(6 a)  $_1$ The relevant **Part B** may stipulate that a mandatory consultation in attendance of the chair of the examination board shall be held during the third semester if the student failed to provide the credit points mentioned above as an alternative to the determination of "ultimately failed".  $_2$ An admission to further course and examination credits requires a proof of the participation.  $_3$ Any unauthorized absence to the purposes of art. 16 para. 2 shall be deemed "ultimately failed".

(6 b)  $_1$ If the student fails to provide any further credit points over a period of four consecutive semesters, the examination board may decide that the Bachelor examination shall be deemed ultimately failed.  $_2$ When taking the decision, the examination board shall take into consideration reasons not to be attributed to the person to be examined or situations of unreasonable hardship.  $_3$ Paragraph 7 and art. 16 para. 2 shall apply accordingly.

(7) <sub>1</sub>Upon a request filed with the examination board, periods of protection used analogous to sec. 3 para. 2, sec. 5 para. 2 and sec. 6 para. 2 of the German Maternity Protection Act (MuSchG) as well as the provisions on parental leave in sections 15, 16 of the German Act on parental benefits and parental leave (German Federal Parental Benefits and Parental Leave Act (BEEG) shall accordingly be taken into consideration. <sub>2</sub>Exemptions pursuant to the German Home Care Leave Act (PflegeZG) shall be equal to subsection 1. <sub>3</sub>The request must be accompanied by relevant documents. <sub>4</sub>Upon the request filed with the examination board, periods of cooperation in the university's panels and boards provided by law as well as in statutory bodies of student organizations at the university shall also be taken into account with up to two semesters.



(8)  $_1$ The examination board shall decide upon the admission to examination components.  $_2$ The admission will be denied unless the admission requirements are met.  $_3$ A special certification will only be issued if the admission is denied.

(9) The admission including the examination dates will be published within the university.

# Art. 11 Evaluation of Examination Components and Modules, Grading

(1) <sub>1</sub>The individual examination components will be evaluated by the relevant examiners. <sub>2</sub>Art. 8 para. 3 shall remain unaffected. <sub>3</sub>Assessors shall be heard before determining the grades. <sub>4</sub>Written examination components shall generally be evaluated no later than four weeks following the relevant examination component.

(2) The following grades apply to the evaluation of examination components:

1.0; 1.3	=	very good	=	an especially outstanding result
1.7; 2.0; 2.3	=	good	=	a result significantly above the average
				requirements
2.7; 3.0; 3.3	=	satisfactory	=	a result meeting the average requirements in
				every respect
3.7; 4.0	=	sufficient	=	a result meeting the minimum requirements in
				spite of deficiencies
5.0	=	insufficient	=	a result no longer meeting the requirements due
				to material deficiencies

<sub>2</sub>If the examination component is evaluated by two examiners, the grade of the examination component is calculated from the arithmetic mean of the individual grades determined by the examiners.

(3)  $_1$ The grade is as follows:

For a mean up to 1.50 = very good

For a mean above 1.50 to 2.50 = good

For a mean above 2.50 to 3.50 = satisfactory

For a mean above 3.50 to 4.00 = sufficient

For a mean above 4.00 = insufficient

<sub>2</sub>When calculating the means, the first two decimals after the point are taken into account, all other digits are dropped without rounding.

(4) <sub>1</sub>If a module consists of several examination components, the module grade is calculated from the mean value, which is weighted according to credit points, of the grades formed for the individual examination components formed according to para. 3 (decimal with two digits after



the point) unless a special weighting is provided in **Part B** of the Examination Regulations. <sub>2</sub>The module grade is shown according to para. 3 in the diploma. <sub>3</sub>If a meta module (art. 6 para. 2) is formed, the meta module grade is calculated from the modules according to subsec. 1. <sub>4</sub>In this case, the meta module grade is shown in the diploma unless **Part B** provides for the modules assigned to the meta module to be shown in the diploma.

(5)  $_1$ When forming the overall grade, paragraphs 2 to 4 shall apply accordingly.  $_2$ Where a module consisting of several examinations also includes study credits, the credit points for the study credit are also taken into account for the weighted calculation of the final grade.  $_3$ Differing provisions may be stipulated in **Part B**.

(6)  $_{1}$ It may be provided **in Part B** that the weighting factor may be reduced by up to half of the credit points for modules of the first three semesters.  $_{2}$ Im A special weighting of the Bachelor thesis with colloquium may otherwise be provided in **Part B** pursuant to sec. 18 para. 1 subsec. 2.  $_{3}$ For programs acc. to art. 4 para. 1, the duration may be extended pursuant to subsec. 1.

(7) The relevant considerations of the evaluation decision will be appropriately documented and filed with the examination records.

(8) For certain preliminary examination components or credits, an evaluation with "pass" or "fail" only may be provided in **Part B** in deviating from para. 3.

(9) The overall grade will be supplemented by a relative classification according to the ECTS Users' Guide as applicable.

(10) For examinations acc. to art. 8 para. 14, the evaluation will be made in consideration of absolute and relative pass marks.

# Art. 12 Pass, Fail, Retaking Exams

(1) <sub>1</sub>An **Examination Component** is passed if it was evaluated with at least "sufficient". <sub>2</sub>If an examination component is evaluated by two examiners, it shall only be deemed passed if both examiners evaluate the component with at least "sufficient". <sub>3</sub>Art. 11 paragraphs 2 and 3 shall apply accordingly. <sub>4</sub>A **Module** is only passed if all examinations required were passed. <sub>5</sub>If an examination component of a module is not even passed in the last possible resit and thus the relevant module is not passed, the Bachelor examination in the relevant program is ultimately failed unless a compensation for such module is provided in **Part B**.

(2) <sub>1</sub>Examination components failed may be retaken twice (resit). <sub>2</sub>Art. 22 shall apply to the Bachelor thesis with colloquium. <sub>3</sub>A second resit in the form of a written examination component may only be evaluated with "insufficient" (5.0) following a supplementary oral examination. <sub>4</sub>The supplementary oral examination will be held by two examiners, art. 11 para. 2 shall otherwise apply accordingly. <sub>5</sub>For a supplementary oral examination, the examination component is evaluated with "sufficient" (4.0). <sub>6</sub>The supplementary oral examination shall be taken immediately after the most recent examination attempt, generally within six semester weeks following announcement that the most recent written attempt to retake the exam was failed. <sub>7</sub>The entitlement to take a supplementary oral examination will lapse after that unless



the failure is attributable to the examiners or the examinee proves to be prevented on the grounds of illness by a medical certificate or has other similar serious reasons. <sub>8</sub>In cases of withdrawal, the examination board shall decide according to art. 16 para. 2 and arranges, where necessary, for a new examination date to be determined by the examiner. <sub>9</sub>In cases of doubt including, but not limited to a repeated notification of illness, the examination board may request the certificate of a medical officer to be submitted. <sub>10</sub>A supplementary oral examination is excluded if the evaluation of the most recent written component is based upon art. 16. <sub>11</sub>Differing stipulations may be provided in **Part B**.

(3) Not applicable

(4) Attempts made in the same or an affiliated Bachelor program within the Federal Republic of Germany to take an examination component will be taken into consideration when considering the possibility to retake an examination pursuant to para. 2.

(5) <sub>1</sub>Students who have passed an examination, may retake the examination in the relevant program at Emden/Leer University of Applied Sciences once to improve the grade (improvement attempt) within the standard period of study; a second improvement attempt in the same examination shall be excluded. <sub>2</sub>Students may make altogether three improvement attempts in Bachelor studies during their studies at Emden/Leer University of Applied Sciences. <sub>3</sub>Unless otherwise provided by the Examination Regulations, there is the possibility to make an improvement attempt for all examinations over the course of studies in the form of written exams and in oral examinations. <sub>4</sub>For module examinations consisting of several examination parts, it may be provided in **Part B** that only the entire module examination may be retaken. <sub>5</sub>An improvement attempt with regard to the Bachelor thesis including Colloquiums is excluded. <sub>6</sub>If the person to be examined obtains another result than the one obtained during the first attempt, the better one of both results is taken into account and included in the calculation of the overall grade of the final examination.

# Art. 13 Announcement

(1) <sub>1</sub>Notwithstanding art. 24, the chair of the examination board shall announce decisions taken by the examination board, including, but not limited to admissions to examinations, periods and deadlines, even examination dates, registration deadlines and other deadlines, with legally binding effect in an appropriate way. <sub>2</sub>In doing so, data protection provisions shall be observed.

(2) <sub>1</sub>The announcement of the results of examination components shall be deemed made three days upon entry into the credit ranking of the university portal; this shall not apply to examination components pursuant to art. 18. <sub>2</sub>Announcements pursuant to art. 13 para. 1 may be made as usual in the relevant faculty by publications on the Internet or by a post on the notice board. <sub>3</sub>In doing so, data protection provisions shall be observed.

# Art. 14 Examination Board

(1)  $_1$ The Dean of Studies shall assume duties pursuant to art. 45 para. 3 subsec. 1 of the Lower Saxony Higher Education Act, NHG.  $_2$ The Dean of Studies or the body delegated by them maintains the examination records.  $_3$ Pursuant to art. 9 para. 2 of the Basic Regulations of



Emden/Leer University of Applied Sciences, the Faculty Council may form an examination board upon the recommendation of the Dean of Studies for support with the execution of examinations. <sub>4</sub>It is also possible to form several examination boards; in any such case, the faculty shall stipulate for what degree courses it is competent. <sub>5</sub>If no examination board is formed, the Dean of Studies shall be competent for all duties assigned to the examination board or the chair of the examination board hereunder.

(2) <sub>1</sub>The relevant Faculty Council shall decide on the size and composition of examination boards. <sub>2</sub>The examination board shall generally consist of five members, that is three members representing the group of university lecturers, one member representing the staff group entrusted with teaching duties as well as one member of the group of students. <sub>3</sub>If there is no staff group, the group of university lecturers is entrusted with this office. <sub>4</sub>An arrangement differing in number and composition may be stipulated in **Part B**. <sub>5</sub>The members of the examination board will be elected by the group of members of the Faculty Council. <sub>6</sub>The chair and the deputy chair must be members of the group of university lecturers; they shall be elected by the Faculty Council. <sub>7</sub>The members who are students shall only have consulting votes when taking decisions on the assessment and transfer of credits and study periods.

(3) The term of the non-student members of the examination board shall be two years, the term of student members shall be one year.

(4) <sub>1</sub>The examination board shall stipulate the periods for holding written exams and oral exams at the beginning of each semester. <sub>2</sub>The examination board shall moreover also determine the date of issuance and due dates of scheduled examinations. <sub>3</sub>For seminar papers, experimental work and presentations in particular, the examination board may assign such duty to the examiners. <sub>4</sub>If several examination boards were set up at one faculty according to art. 14 para. 1 subsec. 4, the stipulation of the periods pursuant to subsec. 1 shall be made by the Faculty Council.

(5) <sub>1</sub>The examination board shall take its decisions with the majority of valid votes cast. <sub>2</sub>In the case of a tie vote, the vote of the chair shall be decisive. <sub>3</sub>The examination board shall have a quorum if the majority of its members including the chair or the deputy chair and another member of the group of lecturers is present.

(6)  $_1$ Minutes are kept on the meetings of the examination board.  $_2$ The material subjects to be discussed and the decisions taken by the examination board shall be laid down in the minutes.  $_3$ The general rules of procedure of the university's panels shall otherwise apply.

(7) <sub>1</sub>The examination board may revocably grant powers to the chair and the deputy chair. <sub>2</sub>Decisions on appeals and decisions on the continuation of studies may not be delegated. <sub>3</sub>Duties related to the organization and execution of examinations and transfers pursuant to art. 17 shall otherwise be transferrable to the purposes of subsec. 1. <sub>4</sub>The chair shall prepare and implement the decisions of the examination board. <sub>5</sub>The chair shall report to the examination board on their activity.

(8) <sub>1</sub>The meetings of the examination board are non-public. <sub>2</sub>The members of the examination board and their deputies shall be subject to official secrecy. <sub>3</sub>Unless they are in public service, they shall be obliged to secrecy by the chair.



(9) Members of the examination board may attend all examinations.

#### Art. 15 Examiners, Assessors

(1) <sub>1</sub>The examination board appoints examiners as well as assessors. <sub>2</sub>Only those members and affiliates of Emden/Leer University of Applied Sciences or other universities may be designated examiners who are appointed to autonomous teaching in the relevant examination subject. <sub>3</sub>Where required, this shall also apply if the power of autonomous teaching was only granted for a subspecialty of the examination subject. <sub>4</sub>Teachers on special assignment as well as persons experienced in professional practice and training may be appointed to hold examinations in appropriate fields of examination. <sub>5</sub>Persons appointed examiners or assessors must have at least the qualification to be determined by the examination or an equivalent qualification.

(2)  $_1$ Examinations by which study programs are completed and last resits shall be evaluated by at least two examiners to the purposes of para. 1.  $_2$ Art. 8 para. 3 shall remain unaffected.  $_3$ Presentations pursuant to art. 8 para. 6 do not constitute an examination to the purposes of subsec. 2.

(3) <sub>1</sub>Students may suggest examiners for oral examinations and for the Bachelor thesis with colloquium notwithstanding the provision in para. 4. <sub>2</sub>The suggestion does not justify any entitlement. <sub>3</sub>The suggestion shall be complied with unless there are important reasons or an unreasonable burden of the examiner suggested.

(4) <sub>1</sub>In the event that examination components are provided over the course of studies, the teacher having the power to hold examinations pursuant to para. 1 subsections 2 to 4 shall be the examiner without being specifically designated. <sub>2</sub>The same shall apply if examination components are provided in relation to lectures responsibly supervised by several teachers. <sub>3</sub>If more persons having the power to hold examinations are available than required for holding the examination, the examiners will be appointed by the examination board.

(5) The examination board shall ensure that the names of the examiners will be disclosed to the students on time, no later than two weeks before the date of the relevant examination.

(6) Art. 14 para. 8 shall apply accordingly.

#### Art. 16 Exceeded Deadlines, Defaults, Withdrawals, Breaches of Regulations

(1) A component shall be deemed evaluated with "insufficient" if the student

- a) Fails to appear for an examination date without good reason, or
- b) Withdraws from the examination following the beginning of the examination without good reason, or
- c) Fails to retake an examination component within the set deadline.

(2) The examination board or the body designated by the board must be immediately notified in writing of the reasons credibly proven for the withdrawal or the default, the relevant



examination component shall otherwise be deemed evaluated with "insufficient".  $_2$ Disenrolment shall not constitute good reason.  $_3$ In the case of illness, a medical certificate stating the duration of the inability to take the examination must be **immediately** submitted, which must be issued no later than on the date of the examination.  $_4$ If the deadline falls upon a Saturday, Sunday or a public holiday, the period will be extended to the next working day.  $_5$ Upon the request of the examination board, a certificate of a medical officer must be submitted unless the illness is obvious.  $_6$ If the reasons are accepted, a new date, generally the next regular examination date, will be scheduled or the examination board will decide on the duration of the extension of the deadline in the event of art. 10 para. 6.

(3) <sub>1</sub>In the event that the due date of an examination component is not met without good reason, the examination component shall be deemed evaluated with "insufficient". <sub>2</sub>Para. 2 shall apply accordingly. <sub>3</sub>If good reason is stated, the examination board shall decide in consideration of the principles of equal opportunities whether the due date for the examination component is postponed accordingly or a new assignment is given.

(4) <sub>1</sub>If students attempt to influence the result of their examination by deception or the use of tools not permissible, if they cooperate in a deception, or if they disrupt the due course of the examination, or if intellectual property of third parties is violated with the intent of deliberate deception or material published by third parties without stating the source/authorship and submitted as their own work (plagiarism), the relevant examination component is generally evaluated with "insufficient" (5.0). <sub>2</sub>In the event of particularly severe or repeated deception, the examination may be evaluated with "ultimately failed". <sub>3</sub>The relevant student shall continue the supervisor. <sub>4</sub>The determination pursuant to subsec. 1 will be made and put on record by the examiners. <sub>5</sub>The decision on the evaluation of the relevant examination component with "insufficient" (5.0) or "ultimately failed" will be taken by the examination board. <sub>6</sub>Before taking any such decision, the student will be given the opportunity to be heard.

(5) If misconduct only becomes known following the completion of the examination and if the candidate has not yet terminated studies, the examination will also be evaluated with "insufficient" (5.0).

(6) Before a decision is taken, the student shall be given the opportunity to make a statement.

(7) An examination component may be verified with regard to copied text passages potentially not marked or other sources by means of a suited plagiarism detection software.

# Art. 17 Recognition of Study Periods, Examination Components and Credit Points

(1) <sub>1</sub>Credit points acquired in a Bachelor program, which were provided at a university of a member state of the Convention on the Recognition of Qualifications in the Area of Higher Education in the European region, shall be recognized upon request without any determination of equivalence to corresponding modules unless significant differences in the competences conveyed can be determined. <sub>2</sub>The proof of burden lies with Emden/Leer University of Applied Sciences.



(2) If students continue studies already begun at Emden/Leer University of Applied Sciences following disenrollment in the same study program, the credits already provided as well as failed attempts will be transferred.

(3) Credits provided at a foreign university outside of the signatory states of the Lisbon Convention shall be recognized if the university or the study program is duly recognized or accredited according to the legal provisions of the country concerned and the applicant proves that the credits essentially correspond to the requirements and competences conveyed of the chosen study program in contents and scope.

(4) <sub>1</sub>Credits provided during studies at foreign universities shall be recognized if the student has the eligibility for recognition confirmed in the form of a "Learning Agreement" before starting the semester abroad by the examination board. <sub>2</sub>The student shall be required to submit the documents required for recognition.

(5) <sub>1</sub>Competences acquired outside of university and at the workplace with regard to learning goals, contents and the level of individual modules or part modules shall be credited upon request if equivalence according to para. 1 is determined. <sub>2</sub>There may be a blanket recognition of qualifications acquired in specialist further training if equivalence according to paragraphs 1 and 2 is determined. <sub>3</sub>The blanket recognition of credits and examination components will be decided by the examination board. <sub>4</sub>The transfer of credits and examination components according to para. 5 shall only be possible up to no more than half of the credit points to be awarded in this study program.

(6) Paragraphs 1 and 2 shall apply accordingly to periods of study, credits and examination components in state-approved distance learning or state-funded distance-learning institutions.

(7)  $_1$ If credits and examination components are recognized or transferred, grades are transferred – if the grading systems are comparable – and taken into account when calculating the overall grade.  $_2$ In the case of incomparable grading systems, the remark "pass" shall be included and the credits thus recognized or transferred shall not be taken into account when calculating the overall grade.  $_3$ If relevant agreements with foreign universities exist, a conversion shall only be permissible.  $_4$ The recognition of transfer will be documented in the academic record.  $_5$ It shall be permissible to mark the recognition or transfer in the diploma.

(8)  $_1$ The examination board shall decide on the recognition or transfer.  $_2$ A recognition or transfer shall be excluded after the relevant examination component is initially taken.  $_3$ The decision on the recognition or transfer shall be taken based upon appropriate information on that qualification whose recognition or transfer was requested.  $_4$ The applicant generally has the responsibility for the providing such information.  $_5$ If the recognition or transfer is refused, this must be justified, and the applicant shall be notified where possible on measures in order to obtain the recognition or transfer at a later point in time.  $_6$ If the recognition or transfer is refused, refused or no decision is passed, the applicant may file an appeal within a reasonable period.

# Art. 18 Bachelor Examination

(1) The Bachelor examination consists of the following:



- 1. Modules completed over the course of studies
- 2. The Bachelor thesis including the colloquium.
- (2) <sub>1</sub>Part B governs the type and scope of the examinations with which the modules are completed. <sub>2</sub>It may also be provided in Part B that a colloquium to the Bachelor thesis pursuant to subsec. 2 does not apply.

# Art. 19 Admission to the Bachelor Thesis

(1) Students are admitted to the Bachelor thesis who

- Passed the modules of the Bachelor examination required pursuant to Part B,
- And have been enrolled with Emden/Leer University of Applied Sciences for the relevant study program at least the last semester before registering for the Bachelor thesis.

(2) <sub>1</sub>In differing from this, Part B may also provide for an admission to the Bachelor thesis if not all modules of the Bachelor examination have yet been passed. <sub>2</sub>This requires that the yet missing credits can be expected to be made up for within a semester without affecting the Bachelor thesis.

(3) The application for admission of the Bachelor thesis shall be filed in writing within the registration period stipulated by the examination board (art. 10).

# Art. 20 Bachelor Thesis

(1) <sub>1</sub>The Bachelor thesis is designed to show that the student is able to autonomously elaborate on an issue of the discipline of the relevant study program on a scientific basis. <sub>2</sub>The type and task of the Bachelor thesis must correspond to the study goal (art. 2) and the period stipulated for completing the work. <sub>3</sub>The Bachelor thesis may be prepared in the form of group work. <sub>4</sub>Art. 8 para. 16 shall apply accordingly. <sub>5</sub>The Bachelor thesis shall be submitted in electronic form. <sub>6</sub>The file format will be published within the university.

(2)  $_1$ The topic of the Bachelor thesis may be determined by each and every member of the group of professors of the faculty to which the study program is assigned.  $_2$ With the consent of the examination board, the topic may also be determined by a professor who is no member of such faculty.  $_3$ It may also be determined by other persons having the power to hold examinations pursuant to art. 15 para. 1; in any such case, one of the examining persons must at least be a professor or in specific justified exceptional cases, a graduated person authorized to hold examinations according to art. 15 para. 1.  $_4$ Art. 15 para. 2 shall remain unaffected.  $_5$ At least one examiner must be a member of Emden/Leer University of Applied Sciences or a cooperation university.

(3)  $_1$ The topic will be disclosed by the examination board.  $_2$ The examination board will take care upon request that the student is given a topic for the Bachelor examination on time.  $_3$ With the disclosure of the topic, the examiner who designated the topic (first examiner) and another



examiner (second examiner) will be appointed. <sub>4</sub>During the preparation of the thesis, the student will be supervised by the first examiner.

(4)  $_1$ The topic of the Bachelor thesis may only be returned once within the first three weeks of the work period.  $_2$ The work period for the Bachelor thesis is stipulated in Part B.  $_3$ An extension of the work period up to an overall duration of a maximum of six months may be provided there.

(5)  $_1$ The due date of the Bachelor thesis must be put on the record.  $_2$ Students must affirm in the Bachelor thesis that they autonomously authored the thesis – in the event of group work, the share of the thesis which is marked accordingly – and used no sources and tools other than the ones stated.

(6)  $_1$ The Bachelor thesis will be preliminarily evaluated by the examiners before the colloquium within four weeks following submission.  $_2$ Art. 11 paragraphs 2, 3, 5 and 9 shall apply accordingly.  $_3$ An autonomous weighting and evaluation of the Bachelor thesis and the colloquium respectively may be provided in Part B, the Bachelor thesis not being evaluated preliminarily, but finally in this case in deviating from subsec. 1.

# Art. 21 Colloquium

(1) In the colloquium, students shall be required to prove and explain in an expert conversation based upon an elaboration on the Bachelor thesis that they are able to autonomously deal with issues from the disciplinary field interdisciplinarily and related to the issue on a scientific basis.

(2) Students are admitted to the colloquium if

- 1. The modules required of the Bachelor examination are passed, and
- 2. The Bachelor thesis is preliminarily evaluated by one examiner with at least "sufficient".

(3)  $_1$ The colloquium will be held jointly by the examiners of the Bachelor thesis as an individual examination or group examination.  $_2$ The first examiner shall have the chair.  $_3$ The duration of the colloquiums generally is 30 minutes per student.

(4)  $_1$ Each examiner forms from their preliminary grade for the Bachelor thesis and the result from the colloquium a final grade for the Bachelor thesis with the colloquium.  $_2$ The mean value from the grades thus determined by the examiners results in the evaluation of the Bachelor examination with colloquium which is relevant to the Bachelor examination.  $_3$ Art. 11 paragraphs 2, 3, 5 and 9 and art. 12 para. 1 shall apply accordingly.

(5)  $_{1}$ If Part B stipulates a separate weighting and evaluation of the Bachelor thesis and the colloquium, the examination board may also appoint its own examiners for the colloquium.  $_{2}$ In this case, the examiners appointed form a final grade for the Bachelor thesis and for the colloquium respectively in deviating from para. 4.  $_{3}$ In this case, the weighting of grades for the overall result of the Bachelor thesis with colloquium is determined pursuant to the provisions of Part B.  $_{4}$ Art. 11 paragraphs 2, 3, 5 and 9, art. 12 para. 1 and art. 22 para. 2 shall apply accordingly.

(6) Art. 8 para. 3 shall otherwise apply accordingly.



#### Art. 22 Passing, Failing the Bachelor Examination, Retaking the Examination

(1) <sub>1</sub>The Bachelor examination is passed if all modules, credits and the Bachelor thesis with the colloquium were evaluated with at least "sufficient". <sub>2</sub>The Bachelor examination is finally failed if a module or the Bachelor thesis with the colloquium is evaluated with "insufficient" or is deemed evaluated with "insufficient" and there is no longer a possibility to retake the examination.

(2) <sub>1</sub>The overall grade for the Bachelor examination is calculated from the mean value of the grades for the modules stipulated in Part B, which is weighted with credit points, as well as the Bachelor thesis with the colloquium. <sub>2</sub>A special weighting of the Bachelor thesis with colloquium may be provided in Part B. <sub>3</sub>For calculating the overall grade, the module grades calculated pursuant to art. 11 para. 4 subsec. 1 (decimal with two digits after the point) shall be taken into account. <sub>4</sub>In the diploma, the overall grade thus determined will be shown with the grades "very good", "good", "satisfactory" or "sufficient" pursuant to art. 11 para. 3, the two-decimal result calculated being shown in parentheses.

(3) <sub>1</sub>For an overall grade from 1.00 to 1.30, the student is awarded the rating "with distinction" for especially outstanding achievements. <sub>2</sub>The rating shall be mentioned in the diploma.

(4) <sub>1</sub>The Bachelor thesis with colloquium may be repeated once unless it was evaluated with "insufficient" or is deemed evaluated with "insufficient"; a second resit shall be excluded. <sub>2</sub>It shall, however, only be permissible to return the topic during the resit if this possibility has not been used for the first thesis already. <sub>3</sub>Art. 12 para. 4 shall apply accordingly.

# Art. 23 Bachelor Diploma and Bachelor Certificate

(1)  $_1$ The candidate is immediately issued a diploma and a supplement to the diploma.  $_2$ The diploma and the diploma supplement include no less than the following information:

- The university, the faculty with location
- The study program
- The topic of the Bachelor thesis
- The grade of the Bachelor thesis including the colloquium
- The list of modules relevant to the final grade with grading and credit points
- The overall grade
- The compulsory modules
- The compulsory elective modules

(2)  $_1$ The diploma includes the date on which the last examination component was taken.  $_2$ It must be signed by the chair of the examination board.  $_3$ It may be provided in Part B that the student is issued a translation in English upon request.  $_4$ A Diploma Supplement in English is enclosed to the diploma.  $_5$ It may be provided in Part B that the student is issued a German Diploma Supplement upon request.



(3)  $_1$ Simultaneously with the diploma, the candidate is awarded a degree certificate bearing the date of the diploma.  $_2$ This certificate is a certification of the academic degree according to Part B.  $_3$ The certificate is signed by the head of the faculty and affixed with the seal of the university.  $_4$ It may be provided in Part B that the student is issued a translation in English upon request.

(4) <sub>1</sub>In the event that the Bachelor program is ultimately failed, candidates will obtain upon request a certification issued by the examination office on the credits provided by them including all failed attempts, or a certification on all credits passed. <sub>2</sub>The same shall apply if students who completed parts of the study program leave Emden/Leer University of Applied Sciences.

# Art. 24 Review of Examination Files and Study Records

(1)  $_1$ Upon request, students shall be granted review of the written examination papers, the remarks of the examiners and the examination minutes following completion of each examination component.  $_2$ The application shall be filed no later than within one year following issuance of the final examination certificate or the certification on the ultimate failing of the examination with the examination board.  $_3$ The board shall determine the place and time of the review.

(2) Upon request, students will be notified of partial results before completion of an examination.

# Art. 25 Invalidity of Examination Components, Withdrawal of the Bachelor Degree

(1) If a deception was committed during an examination or credit and if this fact only becomes known following issuance of the diploma, the examination board may subsequently correct the grades accordingly for those examinations during which the candidate deceived and declare the examination component or credit in whole or in part "failed".

(2) <sub>1</sub>If the requirements for the admission to an examination component were not met without the candidate's intention to deceive, and if this fact only becomes known following issuance of the certificate, such deficiency shall be remedied by passing the examination component. <sub>2</sub>If the candidate unlawfully effected the admission wilfully, the examination board shall decide in compliance with the statutory provisions on the withdrawal of illegitimate administrative acts.

(3) The person to be examined shall be given the opportunity to discuss the matter with the examination board before a decision is taken.

(4)  $_1$ The incorrect final examination certificate shall be withdrawn and substituted by a correct certificate or correct certification pursuant to art. 23 para. 4.  $_2$ The Bachelor certificate and the Diploma Supplement shall also be withdrawn along with the incorrect final examination certificate if the examination is declared "failed" (5.0) due to a deception.  $_3$ A decision pursuant to paragraphs 1 and 2 shall be excluded following a period of five years from the date of the final examination certificate.



#### Art. 26 Case-by-Case Decisions, Appeal Procedures

(1) <sub>1</sub>Decisions of refusal and other burdensome administrative acts taken hereunder shall be justified in writing, supplemented by a note on legal remedy and disclosed pursuant to sec. 41 of the German Administrative Procedure Act. <sub>2</sub>Administrative acts based upon an evaluation affiliated to a professional examination may be appealed against with the examination board within one months following receipt of the notification pursuant to sections 68 et seq. of the German Administrative Court Regulations.

(2)  $_1$ The examination board shall decide on the appeal.  $_2$ Where the appeal is filed against the evaluation of one examiner, the examination board shall decide following revision according to para. 3.

(3) <sub>1</sub>If the candidate files concrete and substantiated objections to evaluations specific to the examination and professional evaluations of one examiner, the examination board shall submit such examiner with the appeal for revision. <sub>2</sub>If the examiner changes the evaluation as requested, the examination board shall remedy the appeal. <sub>3</sub>The examination board shall otherwise revise the decision based upon the statement of the examiner in particular to the effect whether:

- 1. The examination procedure was not properly conducted
- 2. The wrong facts were assumed for the evaluation
- 3. Generally accepted principles of evaluation were not complied with
- 4. A justifiable solution coherently justified by strong arguments was evaluated as false
- 5. The examiner went by irrelevant considerations.

<sup>4</sup>The same shall apply if the appeal is filed against the evaluation by several examiners.

(4) 1Unless the examination board

- Remedies the appeal in this stage of the procedure already, or
- Tangible and substantiated objections to evaluations specific to the examination and professional evaluations exist without the examiner changing their decision accordingly, in the event of a breach pursuant to para. 3 subsec. 3 numbers 1 to 5, the examination components shall be reevaluated by other examiners not previously involved in holding such examination, or the oral examination is retaken. <sub>2</sub>The reevaluation must not result in a lower examination grade.

(5)  $_1$ The appeal shall be decided within one month.  $_2$ If the appeal is not remedied, the university administration shall notify the appellant.

#### Art. 27 Entry into Force

(1) <sub>1</sub>These Regulations shall enter into force on the date following their publication in the Gazette of Emden/Leer University of Applied Sciences. <sub>2</sub>The examination board shall inform students in a reasonable manner on the applicable examination provisions. <sub>3</sub>The previously



applicable General Part of the Examination Regulations of 6 February 2015 as last amended on 4 September 2017 shall simultaneously cease to be in force.
